Dear Minister,

On behalf of our Board of Directors and our members, I write to congratulate you and wish you well as Canada's new Minister of Fisheries, Oceans and the Canadian Coast Guard.

The Federation of Ontario Cottagers' Associations (FOCA) is an incorporated non-profit organization that represents over 500 waterfront property owners' groups, with over 50,000 member families. For over 50 years, FOCA has spoken on behalf of, and supported, Ontario's 250,000 waterfront property owners.

These are challenging times for rural Ontario, and the way forward will have to come through productive and open working relationships between government of all levels, industry, and non-government organizations.

Waterfront property owners represent one of the single largest rural constituencies – over 250,000 families, located in nearly 200 Ontario municipalities who collectively own and steward 15,000 kilometres of the Province's shorelines, and over 50,000 hectares of economically and environmentally important lands.

Rural Ontario is a region where municipal governments rely heavily (as much as 90%) on residential taxes to deliver adequate infrastructure and important services to citizens. Waterfront residential residents contribute more than \$800 million annually in support of rural Ontario's public services through their property taxes.

On behalf of these families, FOCA has worked on many shared and important issues with the Federal and Provincial government in the past: as long-standing partners in delivering water quality monitoring, as supporters of freshwater science, through our involvement with Source Water Protection, and, as supporters of strong and measurable Great Lakes protection in Ontario. Our members have a front row seat for the changes in climatic conditions and are very much exposed to the challenges posed by shifting climates and extreme weather.

Needless to say we have very many touch points with your Ministry and a history of working on shared and important environmental priorities. To this end we look forward to a productive working relationship with you and with your Ministry colleagues in the weeks and months ahead. We are encouraged in this respect by the statements in your mandate directives from the Prime Minister, including meaningful engagement

and more constructive dialogue with Canadians, civil society, and stakeholders, including the broader public sector, and the not-for-profit sector.

As Minister of Fisheries, Oceans and the Canadian Coast Guard, we are heartened by a renewed Federal commitment to protect our freshwater resources and the ecosystems to which they are so integral, to ensure that they remain healthy for future generations.

Specifically, we look forward to results from your commitments:

- to restore lost protections, and incorporate modern safeguards within the Fisheries Act;
- to work with the Minister of Transport to review the previous government's changes to the Navigable Waters Protection Act, and ensure it truly incorporates adequate standards;
- to use scientific evidence and the precautionary principle, and take into account climate change, when making decisions affecting fish stocks and ecosystem management.
- to restore annual federal funding for freshwater research, and make new investments in Canada's Experimental Lakes Area.
- to support the Minister of Environment and Climate Change to renew our commitment to protect the Great Lakes, the St. Lawrence River Basin, and the Lake Winnipeg Basin.
- to work with the Minister of Environment and Climate Change and the Minister of Natural Resources, to immediately review Canada's environmental assessment processes and introduce new, fair processes that will:
 - restore robust oversight and thorough environmental assessments of areas under federal jurisdiction, while also working with provinces and territories to avoid duplication;
 - ensure that decisions are based on science, facts, and evidence, and serve the public interest;
 - provide ways for Canadians to express their views and opportunities for experts to meaningfully participate; and
 - require project advocates to choose the best technologies available to reduce environmental impacts.

We would welcome the opportunity to meet with you at your convenience to discuss how our organization and our membership can positively support and contribute to the interests of the Ministry in the months ahead.
