# **Event Highlights:**

#### FOCA Updates & Reflections on 2020:

Despite all the challenges of 2020, FOCA and our member Associations emerged stronger and more vitally important than ever before. **How did we do this?** 



- by helping volunteer groups shift necessary association business to virtual platforms
- by giving voice to property owners' rights to socially distance at their waterfront residences during the pandemic
- by delivering timely updates and public health recommendations for waterfront communities
- by sharing success stories among lake associations, to inspire each other.

FOCA continues to work alongside partners on programs such as the <u>Lake Partner Program</u> and <u>invasive species</u> prevention and mitigation, including <u>Asian carp</u> awareness, especially for our members on the Great Lakes.

FOCA held many webinars throughout 2020, to keep members informed during the pandemic, but also on topics of perennial interest such as <u>Cottage Succession</u> and Water Level Management, together with emerging issues like the Gypsy Moth. If you missed a webinar of interest, contact us (<u>communications@foca.on.ca</u>) for member access to the recordings.

The Executive Director's presentation also included policy updates, as FOCA was busy throughout 2020 with many files, including <u>rural broadband</u>, supporting <u>Conservation Authorities</u> in the face of Bill 229, and concerns over Ministerial Zoning Orders that threaten good <u>land use planning</u>. <u>Electricity pricing</u> dominated the later part of the year and the beginning of 2021, with the Ontario Energy Board (OEB) order that Hydro One must eliminate the Seasonal Electricity Class of customers, resulting in tens of thousands of families facing large increases in their electricity bills. FOCA continues to hold intervenor status at the OEB, and we launched an <u>online campaign</u> that has already resulted in over 1,800 seasonal property owners writing their MPPs to explain how this change will negatively impact families in rural and remote areas.

I'd like to start by respectfully acknowledging that I'm hosting this webinar from the traditional territory of the Mississauga, Anishinaabeg, and that the waterfront lands of Ontario are home to many diverse First Nations, Inuit and Métis. We offer our gratitude to our First Nations for their care for, and teachings about, our earth and our relations. May we honour those teachings.

**Tires submerged in lakes - an unanswered question!:** One attendee asked a question to which FOCA has no answer. If your association has information, please <u>share it with us</u>:

"Our lake association has found documentation of the placement of artificial reefs for fish habitat composed of used automobile tires in the late 1980's. We are in the process of confirming this and trying to find the reefs. Have any other lake associations found this in their historical documents?"

### **FOCA Annual General Meeting of Members:**

All business to be conducted at the FOCA 2021 AGM was passed, including updating FOCA's bylaws to allow meetings to be held by phone or other electronic means (such as this webinar). Voting was by Zoom Poll, with one voting member from each FOCA Member Association in good standing.

Review all the details in the Official Notice to Members,

including links to download the Minutes of the last AGM, and the audited financial statements for the past year. We had assumed that some of our association members might face difficulty retaining members and collecting fees in 2020, but overall we are pleased to report that FOCA's revenue and expenses have not been significantly negatively affected by COVID-19.

In addition to presenting the financials of the last fiscal year, FOCA's Treasurer Daryle Moffatt presented **budget projections**, which propose:

- Targeting a balanced budget, with any increases in (mostly staff and contractor) expenses covered through project funds
- A modest increase in Association membership dues (as approved at the March 2020 AGM)
- A modest increase in Individual supporters, and other sales revenue (such as our event registrations and sales of DVDs on cottage succession)
- A modest increase in corporate sponsorships
- Anticipated flat third-party contracts (which refers to public sector grant revenues).





On behalf of the Governance and Nominations Committee, FOCA's Board President thanked two outgoing Directors and the 9 Directors continuing in their terms before asking for a Motion to elect 1 Director standing for re-election (for their second 3-year term), and 3 new Directors. ### the Long Point Ratepayers' Association!

The FOCA Achievement Award celebrates the successes of the FOCA community, and encourages us to share success stories and best-practices among member associations. Over the years, the Award has been presented to groups of all sizes, and from all parts of Ontario.

Quite often we recognize associations for their environmental efforts, but 2020 was a unique year, and in this case the recipient Association was nominated under the category "political involvement" for their successful advocacy on behalf of seasonal property owners, as a result of an Order in Norfolk County in late April 2020 from the Haldimand Norfolk Medical Health Officer prohibiting all seasonal property owners from outside Haldimand or Norfolk Counties from occupying their seasonal residences, under threat of fines up to \$5,000 per day.

The Long Point Ratepayers' Association (LPRA) engaged their MPP, brought their plight to the attention of the Premier's Office, as well as the two local Mayors, secured media attention for the issue, and launched an appeal of the Health Order—which was rescinded, just on the cusp of the May long weekend! Throughout, the LPRA encouraged its members to follow social distancing practices and other guidance of the government and Chief Medial Officer of Health.

As we enter 2021 with the potential for more "us versus them" sentiment in cottage country, we congratulate the LPRA for taking actions that were reasoned, well communicated, and highlight the power of speaking with a united voice. There has been no subsequent talk of issuing such an Order again—either in the Haldimand Norfolk Health Unit, or any other place in Ontario.

# The Lake Partner Program 2021

This session was generously sponsored by Yamaha Motor Canada.

Dr. Liz Favot, who has recently joined FOCA as the Assistant Lake Stewardship Coordinator working at the Dorset Environmental Science Centre, presented information about the Lake Partner Program (LPP). Some highlights:

- 25 years of volunteer monitoring
- The largest volunteer-based water quality monitroing program of its kind in Canada
- Over 600 volunteers annually collecting samples and recording water clarity in 550 lakes at over 850 sampling locations, with samples analyzed by the Ministry of the Environment, Conservation and Parks chemistry lab.

support community projects aimed at managing invasive Phragmites. This initiative is providing funding for equipment, materials and supplies, and some professional services. # Association Best Practices: Volunteer Considerations for 2021


This session was generously sponsored by Aviva.

Ontario cottage country was hugely popular in 2020 as the pandemic and travel restrictions led people to isolate at their waterfront properties. All indications are that 2021 will be as

busy, if not busier. We know there will be new visitors and new property owners, some of whom bought their property over the winter, sight-unseen. We expect that education is going to be critical this year, as some of these folks will be having their first cottage country experience.

What would we like them to know? And how will we welcome them, and shepherd them into our community with an understanding of the special considerations of living at the waterfront?

Next, **Ross Fraser of Cade Associates Insurance Brokers** spoke about liability considerations for volunteer associations during the pandemic. To paraphrase *(while noting that this is for information, and not intended as legal advice)*: as of January 2021, Aviva (the underwriters of the FOCA Lake Association Insurance program, which many member Associations use) as well as others' policies, now specifically EXCLUDE coverage for liability protection in connection with any Contagious Disease. However, part of Bill 218 ("Supporting Ontario's Recovery and Municipal Elections Act") which passed in December 2020, prevents legal action from any individual being infected with or exposed to COVID-19, if the organization made a "good faith effort" to act in accordance with public health guidance and laws. Legal action can only be brought if "gross negligence" can be shown. Download a copy of Ross' slides for all the details, from the link on first page of this Summary.



One of the Toolkit resources is an overview for lake associations thinking about holding a digital AGM: <u>Member Offer for FOCA to host Members' AGMs during the Pandemic</u> (PDF, 341 kB). This document has tips for your association executive to review if you're planning your own virtual AGM, and also outlines FOCA's offer to help member Associations to host a basic Annual General Meeting of Members of up to 1.5 hours, on FOCA's Zoom platform, on a feefor-service basis. Details are in the "Member Offer" attachment above, and the final 1.5 pages of the document is a fillable form for you to complete and return to FOCA by email, if you'd like to





discuss this option further. **Please note:** FOCA's digital AGM offer is subject to staff availability, and will not extend to meetings where there are potentially contentious issues to be decided, significant financial decisions being made, or major changes to bylaws or Board structure being voted. The legal experts from Borden Ladner Gervais LLP who hosted FOCA's <u>Association</u> <u>Governance webinar</u> back in May 2020 emphasized that associations should defer votes on contentious issues until after the pandemic; FOCA continues to follow this advice.



# While many organizations cancelled events in 2020, FOCA challenges our member Associations to consider adapting and going virtual with at least one event in 2021.

already have at hand, and what new ones you might need to host an online webinar, a virtual fishing derby or a Friday night Facebook Live sing-along with guitars at the campfire.
