PURPOSE OF THE AWARD

The FOCA Achievement Award is presented to a FOCA member Association each year, at the discretion of the Board of Directors. The award celebrates the successes of the FOCA community, and encourages peer sharing of best-practices.

CRITERIA FOR NOMINATION

Nominees must be current FOCA member associations in good standing.

Achievements or activities may be current or long-term, and should relate to at least one of the following categories:

- environmental stewardship
- land use planning initiatives
- research and/or education
- political involvement
- membership growth and engagement

or any other initiatives in line with FOCA's mission which is: "to protect thriving and sustainable waterfronts across Ontario."

For example, activities could include, but are not limited to: water quality monitoring, successful advocacy and interaction with local government, boating safety initiatives, development of a lake plan, dealings with local service clubs, or innovative programs, events or communications.

Entrants from previous years are eligible for re-nomination. Winners from previous years can reapply based on a new project or different activity.

NOMINATION & SELECTION PROCESS

Any size of association working on any initiative could win this award. We encourage you to apply!

Nominations may be submitted by individuals, associations, umbrella organizations, conservancies, municipal/county/provincial government employees, or any other interested parties.

Nominations consist of this completed form (3 pages) or equivalent submissions **received at the FOCA office by November 30th of the year.**

The recipients of the award will be selected primarily on the Nomination form plus any additional documentation submitted. The Selection Committee will be designated by the FOCA Executive. FOCA reserves the right to select one or more winners in any year, and/or to award a winner as well as "honourable mention(s)."

AWARD PRESENTATION

The award recipient will be announced the following February, and the award is presented at the FOCA Annual General Meeting (AGM) in March.

The award includes a recognition certificate which will be presented to the winning Association by FOCA. An association representative is invited to attend the AGM and present briefly (10 minutes) about the association's projects or accomplishments.
