Grass Carp impacts

Love your Ontario shoreline as much as we do? Invasive Grass Carp eat aquatic plants, and their foraging can disturb lake and river bottoms and uproot large areas of vegetation. This feeding behavior may cause erosion to shorelines, and the lost sediment could reduce the size of your waterfront property and damage nearshore habitats.

Become a part of early detection efforts on Ontario's Great Lakes, by learning how to identify Grass Carp and how to report sightings to the *Invading Species Hotline* (1-800-563-7711) or at EDDMapS.org/.

Trailer watercraft - now regulated under the Invasive Species Act

The *Ontario Invasive Species Act, 2015* has been amended and now **regulates the movement of watercraft** as a carrier of invasive species. The new rules are based on "**Clean, Drain, Dry**" practices, as supported by FOCA and others. update: Muskoka Bin Site Transition Plan

In response to the **Ministry of Environment, Conservation and Parks'** earlier mandate that **The District Municipality of Muskoka** must remove all unlicensed waste bin sites by 2023, the *2021 Annual Report* (outlining progress made to date and plans for 2022) has been approved and released by the District this week. FOCA's local lake association members in the region are engaged in the ongoing process. In particular, properties requiring **winter access to waste disposal on Riley, Leech or Pine Lakes** must sign up for continued service, using links available on the District webpage, where you can also download the 90 page Annual Report and read the results of recent community surveys on waste servicing: <https://www.engagemuskoka.ca/bin-site-transition-plan>



Tracking Wetland Conditions from Space

A binational group of agencies, organizations and universities has been developing a method of tracking the health of Great Lakes wetlands from space. The monitoring can help identify and track the locations of Phragmites, Eurasian watermilfoil or other invasive plants for control measures, or to see how wetland borders are shifting during high or low lake levels. The satellite monitoring project is run by the **Great Lakes Alliance for Remote Sensing (GLARS)**. Read more online here:

ongoing series: Latornell Symposium



Sustainable Great Lakes


