## Digital Expansion

While in-person events were mostly cancelled in 2021 due to the ongoing pandemic, FOCA was busier than ever. Our digital reach has never been stronger and engagement with our community was at an all-time high.

# **Supporting Our Communities**

In our rural communities, things are changing: the exodus to the lake is like nothing we've seen before. Never has it been more important to have a voice for waterfront Ontario – FOCA's role for the past 60 years.



#### Changing Demographics & Succession Plans

Changes in population are the most important driver of house prices in areas of the province outside of large urban centers, and house price appreciation accelerated in 2021, eroding housing affordability. We've seen the signs of a population shift away from large urban centers, toward rural Ontario. This influx has implications for rural utilities, internet and cell availability, garbage, roads, retail, and contractor services in our small towns. FOCA continues to participate in discussions around rural economic recovery, and to educate waterfront property owners about how to manage their own cottage or camp succession plan, as generational shifts in ownership continue.

#### Rural Roads & Short-term Rentals

FOCA stepped up our work around rural roads, as more of our members stretch their time in cottage country into the shoulder and winter seasons, and as liability and maintenance issues have continued to pressure road managers. We are also investigating municipal responses to short term rentals, and continue to support a philosophy of responsible use. FOCA has Working Groups devoted to both roads and rentals, and will continue to release information and facilitate member guidance, such as the "Ask us anything" session about roads at the 2021 Fall Seminar.

#### Sustainability

FOCA reached out to new waterfront property owners with important messages about sustainability, through our participation in the 2021 Virtual Spring Cottage Life event and by publishing a new webpage devoted to welcoming folks to cottage country: <u>https://foca.on.ca/cottage/</u>. #### Be #WakeAware

FOCA launched the campaign in 2021 with our partners at the *Muskoka Lakes Association* and *Safe Quiet Lakes* in response to recent increases in boat traffic, boat power, and new inexperienced drivers. #### "Power Line" Campaign

FOCA encouraged property owners to send letters to MPPs in 2021, letting them know how the Ontario Energy Board (OEB) decision to eliminate the seasonal rate class of Hydro One electricity customers will negatively impact tens of thousands of families. In its final decision released late in 2021, the OEB acknowledged the impact of all this stakeholder input, and has directed that the changes be phased in over a decade which will save seasonal customers thousands of dollars in the interim. ## Environmental Programs

FOCA was busy throughout 2021 on many environmental committees and collaboratives, working on issues that affect all waterfront property owners including land use planning, shoreland best practices, climate change adaption, and source water protection.

#### Clean, Drain, Dry

The environment is feeling the impact of rural in-migration as well. With international borders shut for parts of the year, domestic travel increased in 2021. There were more boats on our Ontario waterways than ever before, and we recognize boats as a potential pathway of spread for aquatic invasive species. FOCA supported the 2021 move to amend the Ontario *Invasive Species Act*: starting in January 2022, watercraft are regulated as a carrier of invasive species. We will help our member groups continue to spread the word about the *"Clean, Drain, Dry"* principles of boat management.

#### IsampleON

In 2021, FOCA helped to launch "*IsampleON*" (Invasive Species Awareness and Monitoring Program for Lakes Education Ontario), a citizen science program for onthe-ground invasive species prevention and detection. Volunteers at 25 selected high-risk lakes monitored for invasive mussels and spiny waterflea, and also collected water samples for some cutting-edge eDNA analysis. #### **Green Shovels Collaborative**

Through the *Green Shovels Collaborative*, of which FOCA is a partner, FOCA funded projects undertaken by our member associations to identify and manage invasive Phragmites at Ontario waterfronts. 
#### **Invasive Carp Species**

In partnership with Fisheries and Oceans Canada, FOCA continues to inform members on the Great Lakes about Asian Carps awareness and prevention. #### Lake Partner Program

The province-wide Lake Partner Program (LPP) has been a shining beacon of citizen science for over a quarter of a century. FOCA's Lake Partners are the backbone of the program, noting water clarity changes through Secchi disk observations and collecting annual water samples which are analyzed by scientists in the Ontario Ministry of the Environment, Conservation & Parks.

This data is available online – now also part of the new Great Lakes DataStream launched in 2021 – and the data informs policy and program decisions, including ongoing research about trends in algal bloom frequency in Ontario lakes. Despite the pandemic, LPP sampling continued in 2021, and just over 100 new volunteers joined the program! Learn more here: https://foca.on.ca/lake-partner-program/.

# The Importance of Elections

2022 is an election year, at the provincial and the municipal level, where services we rely upon are managed including roads, policing and emergency services, parks and recreation, transit, and water. Once every four years, you have an opportunity to vote for your Municipal Councillors and Mayor/Reeve; the next Municipal Election is on Monday, October 24th, 2022. #### Member Associations' Governance Updates

Throughout 2022, FOCA will help guide our incorporated member associations to comply with governance changes under ONCA (the *Ontario Nonprofit Corporations Act*) which finally took effect in late 2021. FOCA has been preparing our members for this moment over the past decade and will update our own organizational documents (henceforth referred to as Articles of Incorporation) and will consider any necessary bylaw updates prior to the October 2024 deadline.
