About FOCA

The Federation of Ontario Cottagers' Associations (FOCA) is a not-for-profit membership organization dedicated to the environmental and financial sustainability of the rural waterfront communities that inspire and sustain us.


FOCA's members are 525 associations across the province, with 50,000 member families. Since 1963, our united voice has carried weight on the issues that matter to waterfront residents, from environmental topics like water quality and responsible land use planning, to "pocketbook" concerns such as fair taxation, availability of rural services, and cottage succession planning.

About FOCA's enduring legacy

On January 7th, 1963, 125 people representing 40 cottage associations met and decided the time was right to form a provincial association. By the spring of 1963, the organization was called The Federation of Ontario Cottagers' Associations. Among the earliest issues discussed were: water quality and water safety, taxation, municipal election voter rights, land use planning and (the lack of) bylaw enforcement.

The landscape continues to evolve, and there is no shortage of topics and files that FOCA engages with, on behalf of our members.

This past year, we worked on important issues like the Underused Housing Tax, floating accommodations, groundbreaking eDNA sampling for invasive species, and the final roll-out of the Ontario Not-for-profit Corporations Act which affects all our Ontarioincorporated associations. FOCA promotes and advocates for healthy lakes, rivers, and watersheds, and is the voice for Ontario's 250,000+ waterfront property owners.






2023: the year that was...

It was a year of weather extremes in Ontario, starting with hot dry conditions and fires across the country in April, and ending as a record-breaker with 741 fires and 441,000 hectares of forests burned by October – almost three times the 10year average!

Properties, forests, animals, and birds were threatened by the fires, and the smoke from fires in and around Ontario blanketed whole swaths of cottage country for months on end, and was carried by the wind far beyond international borders. A powerful Spring storm brought freezing rain, ice, and hail and knocked out power to over a million customers in Ontario and Quebec in early April, while flood watches and tornadoes accompanied extreme summer storms in several parts of the province. The year ended with unseasonably warm temperatures and very little snow; ice-on this winter (2023-2024) took longer than usual.

Overall, 2023 was the warmest summer on record across Canada in the 76 years of national record-keeping.

High water dock impacts

Because Ontario's waterfront residents and cottage and camp owners are located in rural and often remote locations, self-reliance and preparation for extreme weather conditions and emergencies are essential.

Woodland property owners must be proactive and prepared for fire, learn about property risks, and take steps to make their families safer. Get video tips and links to important safety resources from our webpage: https://foca.on.ca/fire-safety/.

FOCA also encourages property owners to be proactive about water level extremes and learn how to prepare for the effects of quick snow or ice melts, heavy rainfalls, or high water flows on lakes or rivers. Cottage country buildings, docks, and boathouses located in or near the floodplain are at particular risk. Preventative action can minimize loss, although extreme events are on the rise and will still have impacts. FOCA reminds members that seasonal properties are not covered by the Ontario Disaster Relief Assistance Program, a financial assistance tool for permanent homeowners. Finally, FOCA continues to advocate for expanded rural and northern access to reliable broadband and cell services for residents as well as emergency responders, and we encourage everyone to learn how to be prepared for personal or regional emergencies in cottage country. We enjoyed reminiscing about all the great work done by the volunteers of this organization over the decades on issues including acid rain, taxation, land use planning, invasive species prevention, and other important programming and public policy work.

Hot Topics, Ongoing Files & Advocacy



Throughout 2023, FOCA engaged with partners and government policymakers on priority issues to ensure that the interests of waterfront communities are represented in relevant decisions related to water management, land use planning, boating safety, fiscal sustainability, emergency preparedness, and rural infrastructure including connectivity issues, among many other topics.

From FOCA's 2022 economic impact study, (https://foca.on.ca/economicwpo/) we know that the quarter-million waterfront property households across Ontario spend an estimated \$11.44B annually. Further, for every 100 waterfront properties in this province, 63 jobs are created, with 54 of those jobs in the local community! Through FOCA, the 250,000 waterfront property owners across this province have a voice, and Ontario's waterfronts have a champion whose input counts with government, industry, and private sector colleagues.

Underused Housing Tax (UHT)

Associations: have you informed your American members about the UHT?

FOCA advocates for fair property taxation on behalf of waterfront residential property taxpayers in Ontario. An Underused Housing Tax (UHT) was implemented by the federal Finance Department in 2022, that was to be payable at tax time in 2023. FOCA requested that seasonal owners be excluded from this tax, and the government brought forward an exemption for Canadian owners of vacation or recreational properties, with certain conditions.

Later in the year, two additional amendments were announced: a push-back of the 2022 filing deadline (to April 2023), and a decision to exclude most Canadian corporations, partnerships, and trusts from the tax. Nevertheless, cottage owners who are neither Canadian citizens nor permanent residents are still required to file a return - and apply to the Canada Revenue Agency for an Individual Tax Number to do so - even if their property ultimately qualifies for a tax exemption. Short-Term Rental Regulation

Short-Term Rental (STR) remained a 'hot topic' for FOCA's members throughout 2023, as municipal Councils implemented a variety of local bylaws, licencing, annual fees, and/or fines intended to address pinch-points created by absentee owners, overuse of properties and surrounding services, and difficulties with bylaw enforcement.

Also in 2023, the federal government announced that property owners in jurisdictions that already prohibit STR will no longer be able to claim rental expenses against the income they make.

Lastly, a precedent was set late in the year when the Township of Minden Hills ruled that a STR property owner was financially responsible for a recreational fire ban fine issued to one of their renters. Rural Connectivity


From FOCA member surveys we know that reliable cellular and internet access remain key concerns across much of Ontario cottage country.

FOCA works with government and partners to advance service access for rural and waterfront Ontario. In 2023, the Province committed additional funds to expand access to highspeed internet, and launched a searchable map to inform property owners about existing and planned projects, with target completion dates. We continue to work with telecommunications and regional partners on this important file. Salt Impacts

FOCA supports efforts to reduce the impacts of salt on our precious freshwaters, in part through our volunteers' monitoring and tracking of chloride levels via the Lake Partner Program. We will continue to work with our partners in academia, industry, and environmental non-governmental organizations to make the case for action.

This year, FOCA participated in a "Salt Forum" convened by Landscape Ontario with over 100 partners, to discuss ecological implications of salt, related infrastructure decline, and safety and liability concerns. Recreational Boating Updates

On behalf of our members who own hundreds of thousands of boats, FOCA sits on the Ontario Recreational Boating Advisory Committee of Transport Canada (TC).

2023 saw several TC developments, including new Pleasure Craft Licensing Fees, and steps toward modernizing the Vessel Operation Restriction Regulations (VORR) that municipalities can use to limit or restrict certain boat traffic or speeds.

After advocacy by FOCA and partners in 2022 on behalf of our member associations affected by shipping containers being used as long-term floating accommodations on Georgian Bay (image above), the Province issued a statement clarifying restrictions on these structures and prohibiting their docking overnight on provincial waterways, effective July 1, 2023. However, any such structures located along the Trent Severn Waterway are under Parks Canada's jurisdiction, so the advocacy continues.

Further, TC designation of these structures as "vessels" continues to pose a challenge to ongoing management efforts. Late in the year, TC opened an initial public consultation period on the issue which they call "long-term anchoring". Stay tuned to the FOCA Elert in 2024 for updates! 

Rural Road Issues

Redstone Lake Cottagers Association

While some of your drive may be on provincial highways or municipally-owned roads, most trips to a cottage, camp, or cabin end along a private road. The quality of your private road can affect both your access to, and enjoyment of, the property as well as its overall value. Local committees, associations, or road groups are an important piece of the puzzle when it comes to private roads.

Some road groups begin as a handshake agreement between neighbours, but evolve over time into more formal organizations, or incorporated entities. Your group might be starting at the very beginning, or you may be fairly well established. Whatever the case, FOCA has a document titled "Starting and Building an Effective Road Association" plus peer case studies on related topics like work plans, benchmark statistics, and getting everyone to pay their fair share. Municipalities & Liability


Throughout 2023, FOCA heard anecdotes from members about municipalities beginning to require rural road residents or associations to carry liability insurance and/or sign a "licence of occupation" for a wide range of uses and activities related to access across unassumed roads, shoreline allowances, or other easements (e.g., for boat launches).

At least one municipality has cut off issuing new building permits until such agreements are signed by property owners. FOCA continues to liaise with rural municipal partners and colleagues at the Rural Ontario Municipal Association (ROMA), the Association of Municipalities of Ontario, and Good Roads (a municipal service organization).

We will keep members updated on developments in 2024 as they become available.

As a service organization dedicated to our membership, FOCA further professionalized our digital offerings by investing in a major web redevelopment that we were proud to launch in 2023.

On the content end of things, over 400 previous blog posts were reordered into 100 topic-driven webpages. Association Best Practices & Templates

For over a decade, FOCA has been helping our incorporated member associations to prepare for the transition to the Ontario Not-for-profit Corporations Act (ONCA).

This is the year you must come into compliance - by October 18, 2024.

If you haven't already, your association should review its Articles of Incorporation (previously called Objects) and Bylaws (sometimes referred to as a Constitution), and ensure that they are updated to address necessary provisions under ONCA. To assist, FOCA has posted tools and links under the member login on our Association Best Practices webpage: https:// foca.on.ca/association-bmps/#onca.

Program **Successes**

One of FOCA's primary goals is to champion the protection and conservation of Ontario's shorelands, lakes, rivers, and watersheds.

By supporting community initiatives across Ontario, FOCA encourages sustainable practices among waterfront residents and visitors, to ensure the long-term health and unique character of Ontario's waterfronts, water quality, and resilience in the face of invasive species and impacts of a changing climate. Here are some quick 2023 program highlights.

Green Shovels – Invasive Phragmites

In recent years, \$60,000 has been distributed through Green Shovels program funding by FOCA, to help member associations in preventing the spread of invasive Phragmites in aquatic environments. Phragmites is an aggressively spreading grass that has become one of the most significant threats to wetland habitats in Ontario, where it drastically reduces plant and wildlife diversity and threatens species at risk. Lake Partner Program

FOCA's signature water monitoring program on Ontario's inland lakes - the Lake Partner Program (LPP) - had its 27th year of operation in 2023.

This renowned undertaking is a longstanding collaboration between FOCA, our volunteer Lake Stewards, and the Ontario Ministry of the Environment, Conservation and Parks who conduct the sample analysis and publish the annual datasets. Collectively, thousands of water quality data points have been generated over the last three decades. In 2023 alone, more than 620 volunteers sampled over 900 sites on more than 540 lakes, producing data that adds to our understanding of long-term trends in Total phosphorus, Calcium, Chloride, and water clarity in our precious lakes.



In the words of sampler Emily Doyle of Otter Lake who has been a waterfront property owner for 40 years, "Until I became a Lake Steward and participated in the LPP, I had no idea what lake health really meant." IsampleON

Dozens of member volunteers across south central Ontario lakes participated in the 2023 Invasive Species Awareness and Monitoring Program for Lakes Education Ontario (IsampleON). This program was launched in 2021 by FOCA and our colleagues at the Invasive Species Centre, and in 2023 was funded by the Ontario Ministry of Natural Resources and Forestry.

We know early detection is essential to protect our lakes and rivers from the negative impacts of aquatic invaders on these key ecosystems.

This year, samplers participated in field work to support cutting-edge eDNA testing - analyzing water samples for traces of genetic material that act like a biological fingerprint unique to each species. This testing has the potential to revolutionize how we monitor the presence and movement of various species in our environment. Thank you for your part in the detective-work, samplers! Boater Pathways for Invasive Species

Over the past 10 years, FOCA has distributed hundreds of free "Clean, Drain, Dry" signs to our member groups, to post at local boat launches and marinas across the province. It is up to every boater to prevent the spread of invasive species when moving boats between waterbodies.

Eyes on the Potential Invasion: Grass Carp

FOCA worked with partners at Fisheries and Oceans Canada to continue to educate our members along and near the Great Lakes about the threat of Grass Carp becoming established in Canadian waters.

These large, voracious invaders - and their fellow invasive species of Silver Carp, Black Carp, and Bighead Carp - could decimate the commercial, recreational, and sport fishing industries in Canada.

We were jarred to have 4 captures of individual Grass Carp at different locations on Lake Erie and Lake Ontario during 2023. We need members living along the Great Lakes shorelines to learn how to identify these fish, and how to report potential sightings.
