

Cottage Succession Seminar Series

FOCA has been "on the road" and "virtual" with **estate lawyer Peter Lillico** for the past decade, bringing information to cottage owners about ways to keep the cottage in the family for the next generation.

How will your family manage the generational transfer of cottage ownership?

Learn what you need to do NOW, to protect the family cottage for the future. These sessions are **free to members of FOCA member Associations**, or \$10 for non-members. Each event is one to two hours total, including the main presentation, and a question and answer session with the estate lawyer on one of the following aspects of the planning:



1. **Cottage Succession A to Z** (this is a 2021 update of the previous introductory session that was called, 'Keeping the 'Family' in the Family Cottage) — Get a cottage succession planning overview, highlighting fundamental legal, tax, and family considerations. This guides through decision-making paths to lead to the best cottage succession plan, with factors including: the age of the parents, number of children interested in continuing cottage ownership, risk factors, financial abilities, capital gains considerations, inheritance timing considerations.



2. **Agreements Avoid Adversity** – Why a **Cottage Sharing Agreement** is the crucial foundation for any shared future family cottage ownership, what protections and provisions they must include, and how best to develop one for your family.



3. **Targeting Tax** – How and when capital gains tax applies; techniques to avoid, reduce or defer tax; and planning approaches to fund it.



4. **Trust the Cottage** – This builds on the article Penny Caldwell wrote in Cottage Life magazine in 2018. A combination of trust techniques can help avoid payment of probate tax, protect against claims by children's creditors and divorcing in-laws, and defer capital gains tax by "generation skipping" ownership.



- 5. **Seize the Time or Bide Your Time**? All parents face the same conundrum: should the changeover be sooner (during their lifetimes, while they are able to be involved in the transition) or later (on death through their Wills). Learn about both.
- 6. **It's All About the Kids** How to choose which kids should become the next owners, help them with the transition, and protect them from risks in the process.
- 7. Cottages at the Crossroads: Choosing the Path This session assumes the cottagers want to keep the cottage in the family and provides an overview of the pros and cons of different succession vehicles: direct personal ownership by children, corporate ownership, or trust ownership.

Keeping the Family in the Family Cottage

This series explains how to plan for your cottage succession to future generations, despite real financial hurdles and inevitable family issues.

Peter's talks and digital recordings, available to FOCA members, consider the many aspects of your family cottage 'plan' including:
