Our Vision

FOCA will continue to be the pre-eminent Ontario-wide organization representing cottagers and permanent waterfront residents.

FOCA is responsible for promoting vibrant and sustainable waterfront communities through effective communication, education and advocacy.

FOCA will:

- Encourage and empower positive environmental stewardship by providing information and tools to members
- Promote and provide leadership for sound public policy on key issues
- Align with other key partners that support like goals and objectives



Here, in our first "Year in Review" publication, it seems timely to reflect upon all that FOCA has accomplished on behalf of waterfront property owners during the past five decades.

In 1963, a small group of cottage owners united as a provincial organization that has grown into a powerhouse representing 50,000 families across Ontario. The issues have evolved over time, but the motivation remains the same: to protect our waterfronts and freshwater resources for our kids, and for their kids.

During the 1980's FOCA fought hard for government action on the issue of acid rain, and lobbied to stop the use of toxic Dombind as a road-dust

suppressant.

Since then, FOCA has secured the voting rights of waterfront property owners in their cottage ridings, and brought the attention of the Provincial Auditor and the Provincial Ombudsman to the shortcomings of Ontario's property taxation system. The fight for fair taxation under WRAFT now continues under FOCA.

FOCA developed a boating hazard marker program approved by Transport Canada, and put together the most comprehensive risk-management program for volunteers in rural environmental groups, through the FOCA Insurance Program.

In 2012, FOCA spoke out against the federal and provincial omnibus bills that gutted protection for our fisheries and fish habitat. This year also saw resolution in favour of land owners' rights during claim-staking, after a decade of behind-the-scenes work on the Mining Act by FOCA and others. Our important efforts continue on the Algonquin Land Claim which affects many of our members in eastern Ontario.

In addition to advocacy efforts, education and communication remain central to our mandate. Over the past decade, FOCA created the award-winning Lake Planning Handbook for community planning, and

delivered face-to-face stewardship support to landowners across waterfront Ontario through the Docktalk program.

For over 30 years, FOCA's Lake Stewards have been at the core of the Lake Partner Program, the world's largest freshwater volunteer monitoring program.

The work continues, and with the support of waterfront property owners and others, FOCA will continue to lead the

effort towards a sustainable freshwater future for Ontario.

In 2012, the FOCA Board undertook a Strategic Review and Planning process to help chart our future course.

From a survey of members in 2011, we learned that lake associations remain FOCA's core customer group. This base is augmented by individual supporters, corporate sponsors and partners, road associations and regional affiliate groups.

We learned that FOCA is highly valued for our advocacy role ("FOCA is our voice") and for our ability to collaborate with and communicate amongst waterfront property owners, environmental scientists, political representatives and disparate partners in the public and private sectors. We also know that you value our digital publications (the FOCA website and monthly Elerts—our email newsletter updates) as well as face-to-face events (the AGM and Fall Seminar, the Cottage Succession Series, and FOCA's participation in lake-level gatherings). 



In order to ensure that FOCA can continue to deliver on our important mandate, the organization must be adequately resourced. We have a well-established funding mix that combines membership fees, government contracts, fees for services, and nonmember private sector contributions to support FOCA operations.

FOCA receives funding from government partners where we can assist with the delivery of programs like the Lake Partner Program, or fire safety messages on behalf of the FireSmart program of the Aviation, Forest Fire and Emergency Services of the Ministry of Natural Resources.

We recognize the trend toward reduced environmental grant funding in the foreseeable future, as a result of ongoing reductions to government budgets. FOCA will rely increasingly on membership fees that are fairly distributed amongst our large and small member groups, augmented by expanded fee-for-service offerings and targeted corporate sponsorships to fund outreach programs.




